

Series entry 2009 – that's the way to do it

1. Fill in the suscription to the Club Sportbike 2009 (which is the next page)

2. Fill in the series entry 2009 (the following 3 pages) for the complete season

3. and that's it

- Series entry and membership of the Club Sportbike for the current season belong together.
 - The series entry is the fix entry for all marked races.
 - This saves you entering for the individual race. Your place on the grid is secure and you cannot miss the entry closing date. The entry fee will be withdrawn from your account 6 weeks before the respective event or, (if you have a German bank account) via bank transfer after receiving the entry confirmation.
 - If you cannot make it to a race, your entry fee will be paid back (- 25 E), if you cancel the entry before entry closing date in written form. After entry close date your entry fee will be refunded if you cancel your entry showing a medical confirmation that you cannot compete.
 - Only series starters can claim and select a permanent start number within the number window defined for the respective category indicated on the entry form.
 - Series starters in the less entry fee per race and per Perfection entry and will be rewarded with bonus laps depending on the entry fee amount:
(100 € = 10 bonus laps = 10 € bonus). For the 210 € option there are neither reduced entry fees nor bonus laps.

- Club Sportbike members racing on Bridgestone tyres can purchase Bridgestone tyres at the Bridgestone service at extremely favourable conditions after showing their club Sportbike Card. The privilege is limited to 10 sets per season for 265 E (120/180) or 269 E (120/190)

Exclusion of Liability

Titel of the event:

The participants (competitors, drivers, co-drivers) participate in the events at their own risk. With respect to civil and criminal law they shall assume the sole liability for any damage caused by them or the vehicle used by them unless exclusion of liability is agreed.

With the submission of this entry competitors, drivers and co-drivers agree to waive any claim with respect to any damage that might arise in connection with the events against

- FIM, UEM, DMSB, the member organizations of the DMSB, the Deutsche Motor Sport Wirtschaftsdienst GmbH, their presidents, bodies, managing directors, secretaries-general
- the districts of the ADAC, the promoter/organizer of the series
- the organizer, stewards, the owner of the race tracks, authorities, racing services as well as all other persons connected to and/or associated with the organization and/or management of the event
- the body/person in charge of and liable for the construction of the streets and roads used in the course of the event, provided any damage caused is due to the condition of the aforesaid streets and/or roads including auxiliary equipment used in the course of the event, and
- the vicarious agents and vicarious officers of all the persons and bodies mentioned above.

This aforementioned waiver shall not apply to any damage arising from wilful or negligent breach of duty – including any such breach of duty by any legal representative or vicarious agent of the category of persons absolved from liability - and leading to injury to the life, body or health; in addition, this waiver shall not apply to any other damage arising from wilful or grossly negligent breach of duty – including any such breach of duty by any legal representative or vicarious agent of the category of persons absolved from liability.

Against

- the other participants (competitors, drivers, co-drivers), their helpers, the proprietors, owners of the other vehicles,
- the own competitor, the own driver/s, co-driver/s (contrary special agreements between competitor/s, driver/s, co-driver/s shall have priority!) and own helpers

competitors, drivers and co-drivers shall waive any claims with respect to any damage arising in connection with the competition (untimed practice, timed practice, warm-up, races, special stage) except for damage arising from wilful or negligent breach of duty – including any such breach by any legal representative or vicarious agent of the category of persons absolved from liability - and leading to injury to the life, body or health; in addition, this waiver shall not apply to any other damage arising from wilful or grossly negligent breach of duty – including any such breach by any legal representative or vicarious agent of the category of persons absolved from liability.

For all parties involved the exclusion of liability shall come into effect with the submission of the entry. The exclusion of liability shall apply to claims arising from any legal ground, in particular to compensation claims arising from contractual as well as non-contractual liability as well as from claims arising from tort.

The above liability exclusion clause is without prejudice to any tacit exclusion of liability.
